Path of Hope is a Rapid Rehousing program targeting homeless families with minor children or expectant mothers. The Brevard Homeless Coalition (BHC) will use the existing Coordinated Entry process to refer families and for this program. Families from our existing shelter and outreach programs are be submitted to coordinated entry. This program will move households out of outreach and shelter programs, providing a path out of homelessness, a Path of Hope. Coordinated Entry prioritizes households based on the priorities established by the CoC. Households of high acuity will be prioritized based on this coordinated entry program. Path of Hope will ensure that these families and others who are referred for rapid rehousing have efficient access to housing within the housing first model framework. A case manager will work with each of the families to complete the SPDAT, enter all pertinent data in HMIS, identify resources at the family's disposal, detect obstacles to rehousing, provide links to other services the family may require, and navigate a "Path" with the family into permanent housing. Community of Hope has developed strong ties with other agencies by forging partnerships, developing new and innovative programs, and participating in all the Coalition's efforts to put an end to homelessness in Brevard County. COH will leverage these relationships to find housing quickly and ensure that families receive the wrap-around support needed to attain housing and maintain it. To this end COH will provide ongoing case management with families who come through the Path of Hope Program for up to 12 months and will refer families for further support as needed. COH will maintain quality data and incorporate this data into our existing Strategic Plan. Path of Hope Rapid Rehousing funds will not be used to house families in Community of Hope housing. Other housing providers including Housing for Homeless, North Brevard Charities, and a vast network of private landlords, have historically worked well with COH and will be a key component in the continued success of the Path of HOPE program. Therefore, COH will continue to cultivate these relationships in order to better serve families in Brevard. We are also committed to expanding our own capacity to provide affordable housing for families coming out of homelessness, having added four more units in 2022 and further expanding the inventory of affordable housing 2023. In short, COH is committed to using whatever tools we have at our disposal to end homelessness, especially child homelessness in Brevard County; Path of Hope will help us fulfil this mission. We will conduct regular reviews of HMIS to ensure data quality and completeness, keeping in mind the priorities of the CoC.



- Housing Navigation. Grant funds can be used to pay staff time necessary to identify safe units and facilitate moves into housing for survivors through emergency transfer(s).

- Technology to make an available unit safe. Grant funds can be used to pay for technology that the individual believes is needed to make the unit safe, including but not limited to doorbell cameras, security systems, phone, and internet service when necessary to support security systems for the unit, etc.
