Heritage Park, located at 2550 Grant Avenue, is an affordable/supportive housing community in the heart of Melbourne with 108 apartments, a health clinic, and ample common space/amenities to truly create a sense of community within the development.

The overarching goal of Heritage Park is to provide homeless residents who are disabled with voluntary, self-directed and recovery-based services within a supportive community that promotes residential stability, self-determination, wellness and independence. This proposal is to request funds to provide a portion of one (1) FTE for a Lead Housing Services Coordinator to coordinate the provision of all services including Intensive Housing Case Management (ICM) and service coordination for 15 homeless residents with disabilities and high service needs living at Heritage Park. Key outcome measures include long-term housing stability, income growth, and quality of life. Intensive supports are voluntary, individualized, recovery-oriented, and provided for as long as needed to ensure long-term housing stability.

A key component of service delivery at Heritage Park is provided by partner The Brevard Health Alliance ("BHA"), who has a 1,100 square foot on-site health clinic. These services will include primary care, behavioral health, dental, preventative screenings, women's health, and pharmacy. In addition, access to specialty treatment for Hepatitis C, HIV, as well as Tobacco, Alcohol, and Opioid Use Disorders, which are all over-represented in the high-need homeless population. Housing and healthcare services will be closely linked at Heritage Park.
