The CoC Lead Agency, Brevard Homeless Coalition (BHC) employs a full-time Coordinated Entry Specialist (CES) staff position focused on the oversight of the CE system including diversified and street outreach efforts countywide. coordination of the provider agencies participating in the CE system, quality of the documents submitted, guidance on the CoC CE assessment tools, data quality and performance and data quality measures. The CES holds weekly calls to discuss questions on referrals, outstanding client issues, and once a month, case conferencing with the case managers/workers. This intentional staffing signals to the CoC and community the importance of coordinated entry to our system of care. The CE system is a low barrier access point system. Access points (AP) into CE can be via street outreach, 211 Brevard (a 24/7 community helpline), at designated access points (for example, sharing centers that also serve as food/clothing pantries and other support services), in emergency and DV shelter programs. Access points are located throughout the County and are classified as fixed, mobile, and telephonic. Households may present at fixed access points such as the service providers or shelters, engage with outreach workers (mobile access points), or contact 211 Brevard (telephonic). Each AP is designated as "closed" or "open" in terms of how it engages w/CE: open access points will assist any household with entering CE; closed access points assist only households enrolled in their program. Any AP should assist households in accessing a different AP if it would better suit their needs. APs engage the household, conduct initial triage, enroll the individual or family in HMIS pending a signed Release of Information, and attempt diversion. If diversion is unsuccessful and it is determined a housing intervention is the next step, the AP can complete a Housing Assessment (VI-SPDAT and CoCspecific Housing Rubric), verify, and document homelessness and refer the household to the prioritization que in HMIS. While the client is waiting for the housing intervention, case workers in the AP check-in on households every 30 days and document interaction in HMIS or they fall out of the que. In addition to checking in, APs continue to engage the households, help gather documentation for those that may meet HUD's definition of chronic homelessness and stay engaged until enrollment into a housing program. Housing and Case Management providers (HP) submit vacancies in their programs via HMIS as they become open through a new electronic process in HMIS which allows for real time updates to housing openings. The BHC CES reviews housing opportunities, filters the prioritization gue according to policy. applies eligibility criteria, and distributes the proposed referrals to the AP and HP via the electronic process in HMIS. This new process allows a quicker turnaround time for openings and referrals and is a "closed loop" system within HMIS. The BHC staff confirms match/referrals and ensures a warm handoff. The program is explained, and the client can reject or accept the referral. If rejected, they are returned to the que. If accepted, the HP finalizes eligibility documentation and enrolls client into their program in HMIS. The CE system needs oversight from a full-time paid staff member. The Coordinated Entry Project funds will support this staff position to ensure that those most in need within our community receive the services designed for them.

The advertisement strategy for the CE process relies heavily on our street outreach workers and the outreach plan for our County. The BHC hired a dedicated Coordinated Entry and Outreach Specialist, to work full time on the coordinated entry system and implement the outreach plan. The BHC Coordinated Entry and Outreach Specialist oversees the marketing and communication of this process and connects with provider and other agencies to solicit and train potential outreach workers. Outreach workers engage with the CoC Lived Experience committee to discover the best methods to reach those with the highest barriers to accessing assistance, for example, no access to the internet or a phone. Lived experience committee members work with the outreach teams to connect with the chronic homeless in our community. We use the by-name list in our HMIS database to identify and reach out based on geographical location in the community with partner organizations. The BHC provides education to the faith community, advocacy groups, law enforcement, and health care systems to equip them in knowing how to help someone navigate the system. Our ADA compliant website includes tools and easy to use materials for this process. Included in the marketing plan is the creation of materials to hand out during the Point in Time count. We will remove communication barriers to reach all people, including those most in need by using all forms of communication, the use of HMIS, our website, outreach workers, faith communities, law enforcement, marketing tools and training. The outreach plan will also be marketed through the SHARE goal in our 2023-2026 strategic plan: Housed & Healthy Brevard.

4e. Describe the referral process and how the coordinated entry process ensures program participants are directed to appropriate housing and services.

All of our member agencies participate as an open or closed access point for services. Open access means they will provide the intake, diversion, and assessment for any household that engages with them. Closed access points are member agencies that will provide the intake, diversion, and assessment for any household that meets their criteria. The households that do not meet the closed access points criteria are referred to 211 Brevard for intake. 211 Brevard is a telephonic open access point that provides intake, diversion, and assessment for any household that contacts them for housing assistance. Both open and closed access points verify homelessness for each household. If a household doesn't meet the HUD definition of homelessness, they will refer the household to member agencies that provide homeless prevention services. Once the household is verified homeless, a VI-SPDAT and CoC-specific Housing Rubric are completed and entered into HMIS. The access point staff will complete and upload the Housing Assessment Plan into HMIS. The questionnaire identifies housing barriers and preferences for each household that can assist in housing problem solving. The household will be entered into our Coordinated Entry project and will be put on our waiting list as individual or family. Access point staff will continue to engage in problem solving conversations. The household will be reviewed for matching with an appropriate agency, and the access point staff will maintain contact with the household until they are referred and accepted by an agency. The matching component is comprised of the BHC's Coordinated Entry Specialist reviewing the information on the individual household needs then reviewing our member agencies capabilities and experience to ensure the best possible match is made for the household and member agency. This past year the CE specialist worked with our HMIS vendor to create a referral and match process conducted electronically within HMIS as a closed loop system. There is reported high satisfaction with this process. If the match is rejected at this point, the household will be returned to the wait list and another match will be attempted. If the match is approved a warm hand off between agencies is conducted.

- Technology to make an available unit safe. Grant funds can be used to pay for technology that the individual believes is needed to make the unit safe, including but not limited to doorbell cameras, security systems, phone, and internet service when necessary to support security systems for the unit, etc.
