3B. Project Description

1. Provide a description that addresses the entire scope of the proposed project.

The Homeless Management Information System (HMIS) is a web-based client and case management tacking tool used by service provider agencies serving individuals and families who are at risk of or experiencing homelessness. The system facilitates the client-level collection, analysis, and reporting of housing, supportive and financial services and unduplicated counts of individuals and families receiving these services. It is the intake and referral hub for the CoC's coordinated entry system. For the past two years, the Brevard Homeless Coalition (BHC), the CoC Lead agency, has been responsible for both CoC and HMIS operations. Through the HMIS Lead Administrator, a BHC staffed position, we are able to respond more quickly to issues surrounding our HMIS System, such as data quality errors, training needs, project creation, and more. Our response time is currently 24-48 hours for responding to service and report requests. We recently unveiled a new process by which trained users can submit technical assistance requests through an online User Portal. We also continue to provide cross training within the organization to ensure the best service to our providers, especially with our Coordinated Entry Specialist and Contracts and Program Director. The cross training and internal communications have led to innovation in the internal coordinated entry process by making our agency referral process electronic with a time limit of accepting or rejecting a coordinated entry referral (a "closed loop" system). Agencies participating in coordinated entry report high satisfaction with the new closed loop system. We work closely with our vendor, Bell Data to implement efficiencies within our HMIS. This past year, we have focused on new management and onboarding process for both existing and new agencies and end users. This process entailed conducting an assessment of our existing agencies for use of the system and CoC function, revisions to the HMIS Data Standards (with enhanced security protocols), a move to digital signatures for participating agency agreements and user agreements, and an online onboarding process. All users were trained/re-trained in HMIS to level set knowledge of the system, and as part of the internal process flow, the HMIS Lead Administrator will be notified when each user is due for annual training. The User Portal was also added to better the technical assistance tracking process, including the request to add a new user to the system. We are currently in conversations to incorporate our local Career Source Brevard referral tool, Crosswalk, for case workers to directly refer their clients to employment and other agencies for increased job growth, income, and employment skills. As we refine our HMIS to meet the needs to the community and our case workers, we seek to make HMIS to go-to, "one stop shop" system for our providers.

HMIS also plays a key role in our new 2023-2026 strategic plan: Housed & Healthy Brevard. With reporting capabilities from the system, such as the SPMs and Housing Inventory Count among others, the BHC and partners can tell the story of homelessness, based on data, in our community (Strategic Plan goal: SHARE).

As the Lead Agency for the CoC, the BHC is responsible for developing, implementing, and updating annually the governance charter, as well as procedures and policies needed to comply with HUD and HMIS data reporting requirements. This past year we undertook the process to update the HMIS policies and procedures. A thorough review of the existing policies and procedures was undertaken, specifically in terms of security protocols and alignment with the HMIS User Policy, leading to revised policies and procedures. This is part of our responsibility to review, revise and approve a CoC HMIS data privacy plan, data security plan, and data quality plan. We also ensure that the HMIS is administered in compliance with HUD requirements; and ensure consistent participation by CoC agencies and ESG recipients and sub-recipients in the HMIS. The BHC Lead Administrator works closely with the Data and Performance Monitoring Committee which reviews policies and procedures and identifies performance measures that the CoC can use to measure progress and the performance of funded projects.

There is a full-time BHC staff member, the HMIS Lead Administrator, who is responsible for ensuring that HMIS implementation meets all privacy and security standards as required by HUD and other federal partners. They also work in concert with partner agencies to ensure that their administrative officers and all end users documenting in the system have signed Partner Agency and end user agreements. These agreements spell out the requirements for data privacy, security, and all protocols for ensuring the protection of client data is of the utmost importance. As part of the annual HMIS training, data privacy and security are reviewed and discussed.

As the CoC and HMIS Lead Agency, the BHC manages any breaches to PII in HMIS. With violations to PII set forth in HMIS policies and procedures, agencies and end users understand that breaches may have serious consequences. Any deliberate or unintentional action resulting in a breach of client confidentiality or loss of data integrity will result in the withdrawal of system access for the offending entity. A user found to have breached the HMIS User Agreement, or violates any Policies or Procedures, or breaches confidentiality or security, the User's access to the HMIS database will be deactivated. Users that are found to be accessing the HMIS from locations outside the Partner Agency facilities without prior approval shall have the user account deactivated. Users divulging any client private protected information for any reason, shall have the user account deactivated. In this matter, the decision of the HMIS Lead Agency is final.
